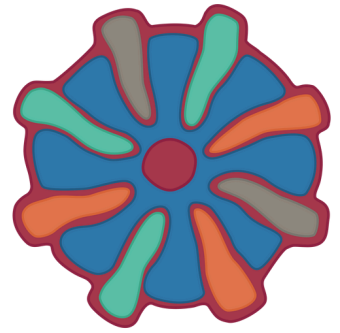

### ABORIGINAL CULTURAL HERITAGE

ALS provides practical advice about the management frameworks and approval processes that protect Aboriginal heritage and how they relate to your project. ## ➤ CULTURAL LANDSCAPE APPROACH

We are majority Aboriginal owned and led, making us one of the largest Aboriginal-owned heritage consultancies in Australia. We are registered with Supply Nation and the Aboriginal Business Directory WA.

We sit on a number of WA State Government preferred supplier panels, including the Water Corporation and Main Roads WA.

## ➤ INFRASTRUCTURE SPECIALISTS

We specialise in environmental and Aboriginal cultural heritage management and cultural place-making for large, complex infrastructure projects and we are familiar with the scoping, budgets, timelines and critical pathways required. We adopt a project management methodology to ensure projects come in on time and on budget.

Our staff are well versed in the safety requirements in challenging environments due to our extensive experience in remote fieldwork programs for mining and exploration resources. Our portfolio of urban projects has given us experience working alongside heavy machinery, busy infrastructure routes and in public spaces, without compromise to safety.

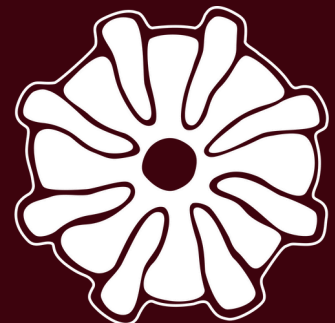
