We apply a cultural landscape perspective and approach to our work, to assist clients to truly understand, protect and celebrate our unique Aboriginal cultural heritage and environmental values, and to build an appreciation of the intrinsic links and interaction between Country, culture and people.

We are majority Aboriginal owned and led, making us one of the largest Aboriginal-owned heritage consultancies in Australia. We are registered with Supply Nation and the Aboriginal Business Directory WA.

# Giving Back

#### UNIVERSITY SCHOLARSHIP

In partnership with the University of Western Australia, we have created a University scholarship worth \$5,000 per year to an Aboriginal student who

is interested in a future career in cultural heritage or Land Management. This scholarship also has an option of paid work experience with ALS and our key partner organisations, Kooyar Wongi and Terra Rosa Consulting.

## DEPARTMENT OF BIODIVERSITY, CONSERVATION AND ATTRACTIONS (DBCA) | PROPOSED MARINE PARK EXPANSION

#### ABOUT THE PROJECT

In 2022, the Department of Biodiversity, Conservation and Attractions (DBCA) proposed an expansion of marine parks across Whadjuk, Minang, Goreng and Mirning coastal waters — areas of immense cultural and ecological value.

Aboriginal Land Services (ALS) was engaged to lead Aboriginal consultation and ensure Traditional Owner knowledge shaped the design and management of the proposed Marmion and South Coast Marine Parks. This included cultural mapping, heritage planning, and collaborative workshops across multiple communities. The project demonstrates how Indigenous knowledge and values can be meaningfully embedded into environmental planning — ensuring conservation efforts also protect culture, identity, and connection to Country.

#### **ALS' ROLE**

- Facilitated cultural mapping and values sessions with Traditional Owners across Whadjuk, Minang, Goreng, and Mirning regions
- Provided cultural and environmental advice to ensure marine planning reflected Aboriginal knowledge systems
- Led workshops and one-on-one consultations to identify cultural values, aspirations, and concerns
- Supported the co-development of heritage and joint management plans with DBCA
- Advocated for the inclusion of underrepresented groups, including direct support for Mirning Traditional Lands Aboriginal Corporation
- Reviewed draft management plans and provided recommendations to strengthen cultural integration

#### IMPACT

This project set a new benchmark for integrating Aboriginal cultural values into environmental planning. Through ALS's facilitation, Traditional Owners were not only consulted but actively involved in shaping the future of marine conservation along the South Coast. The cultural mapping process led to the direct inclusion of Aboriginal knowledge in zoning recommendations and long-term joint management planning — embedding cultural values into the core of decision-making.

The success of the process has led to further collaboration with the Department of Biodiversity, Conservation and Attractions (DBCA) and opened the door for more Aboriginal corporations to influence future land and sea management frameworks. By creating a space for genuine dialogue and cultural leadership, ALS helped shape a more inclusive and culturally resilient future for Western Australia's marine parks.

#### ONGOING OUTCOMES

ALS continues to support the review and implementation of management plans, helping Aboriginal communities remain central to marine conservation. The project has become a model for respectful engagement and joint management in WA.

## CAUSEWAY PEDESTRIAN & CYCLIST BRIDGE | AWARD-WINNING PLANNING PROJECT

#### ABOUT THE PROJECT

The Causeway Pedestrian and Cyclist Bridges Project is a significant infrastructure upgrade, linking East Perth and Victoria Park across the Derbal Yerrigan (Swan River) via Matagarup (Heirisson Island)—a place of deep cultural significance for Whadjuk Noongar people. Given the potential impact on Aboriginal Cultural Heritage, ALS was engaged to lead Noongar community engagement and heritage assessments, ensuring the project respects and celebrates the area's cultural values.

#### ALS' ROLE

- Noongar community engagement & consultation, including the establishment and facilitation of the Matagarup Elders Group (MEG).
- Heritage assessments, including archaeological and ethnographic site identification surveys.
- Development of an Aboriginal Cultural Heritage Management Plan (ACHMP) to guide ongoing cultural heritage protection.
- Monitoring of ground disturbance works by Traditional Owners to safeguard cultural sites.
- Cultural interpretation and placemaking, integrating Noongar knowledge into the project's design.


#### **IMPACT**

This award-winning project has redefined what it means to 'plan with Country'. Key Noongar cultural elements are now woven through the bridges' design — including the striking Wana (digging stick) and Kylie (boomerang) pylons, a dedicated corroboree space, and interpretive signage that educates the public and honours Aboriginal connection to place.

In 2024, the project was recognised with the Planning Institute of Australia WA Award for Planning with Country. ALS is proud to have helped shape this national example of best practice in Aboriginal heritage integration.

#### ONGOING OUTCOMES

ALS continues to support the Causeway Link Alliance by ensuring that Elders remain part of decision-making as the project progresses. The success of this work has also led to new opportunities — ALS has since been approached to undertake similar roles in other major infrastructure and precinct planning projects across the Perth metro region.

## SOUTH REGIONAL TAFE CULTURAL SPACES PROJECT | YARNING CIRCLE AND BUSHTUCKER GARDEN

#### ABOUT THE PROJECT

The project involved the co-design of a cultural space in collaboration with Noongar Elders and Traditional Owners, ensuring that local knowledge and cultural values were embedded from the outset. Central to the space is a permanent jarrah yarning circle, constructed with natural stone pavers to provide a grounding place for connection and learning. The garden features bush tucker plants and seasonal native species carefully selected to reflect the six Noongar seasons —Birak, Bunuru, Djeran, Makuru, Djilba and Kambarang—creating a living, waterwise landscape that is both educational and environmentally sustainable.

#### ALS' ROLE

- Led the co-design process in collaboration with Noongar Elders, Traditional Owners, and TAFE staff
- Provided cultural advice to ensure the space reflected local knowledge and Noongar values
- Designed the garden layout around the six Noongar seasons and native bush tucker species
- Delivered cultural engagement sessions with students to support ongoing use and understanding of the space
- Advised on sustainable planting, waterwise design, and long-term environmental impact
- Coordinated cultural artwork concepts for signage and interpretation within the space

#### **IMPACT**

The Cultural Spaces project has had a lasting impact on both the environment and the community. By embedding cultural knowledge into the design, the space not only supports biodiversity through native, waterwise planting, but also fosters cultural pride and learning. Students are now able to engage with Noongar seasons and traditional bush foods in a hands-on way, building awareness of sustainable practices and cultural responsibility.

The project has created a space for reflection, education, and connection to Country that will grow with the school community over time, supporting long-term environmental stewardship and cultural understanding.

#### **ONGOING OUTCOMES**

The space is regularly used for cultural events, educational workshops, and staff development sessions. ALS continues to support cultural integration across the TAFE's environmental programs, with plans to expand similar initiatives across regional campuses.

Gnaala Karla Booja Aboriginal Corporation (GKB) is one of the six regional corporations established under the 2021 Southwest Native Title Settlement to represent the rights and interests of each of the six Agreement Groups across Noongar Country. The settlement is the biggest to date in Australian history, with the Gnaala Karla Booja region covering the Noongar language or dialectical groups of the Binjareb/Pinjarup, Wilman, Wadandi and Ganeang peoples.

Successfully establishing the GKB has been a mammoth task, including managing the significant legal requirements and expectations from all tiers of government, development proponents and GKB members. Aboriginal Land Services (ALS) approached GKB during the early part of this journey, offering their professional services and advice to help support GKB during this time.
